## MLA Expense Disclosure Report (EDR) Information

## **About the Expense Disclosure Reports:**

At its November 6, 2012, meeting the Special Standing Committee on Members' Services adopted the following policy on MLA expenses reporting and disclosure:

- A) Expenses related to accommodation, meals, hosting and travel as authorized by the Members' Allowances Order, Constituency Services Order, and the Transportation Order, and approved for reimbursement by the Legislative Assembly Office be disclosed.
- B) The information disclosed must include both financial and non-financial aspects of claims made pursuant to the Orders identified in Part A.
- C) Information disclosed publicly by the Legislative Assembly Office pursuant to this policy must include the following:
  - Name and position of individual who incurred the expense;
  - Date of transaction;
  - Transaction amount;
  - Expense category (travel, including transportation, accommodation, meals and incidentals, and hospitality);
  - Description and rational for meals and hosting; and
  - Supporting documentation including receipts when applicable.
- D) Expenses incurred on January 1, 2013 and thereafter will be disclosed by the Legislative Assembly Office 30 days after the conclusion of each quarter in the fiscal year starting April 30, 2013 on the publicly accessible website hosted by the Legislative Assembly Office.
- E) Information must be redacted from supporting documentation and not be publicly disclosed consistent with the requirements of the *Freedom of Information and Protection of Privacy Act*, (for example, if a meeting was held with and individual not affiliated with an organization, then the terms "stakeholder" or "constituent" could be used).

The expense disclosure report requirements apply to Members of the Legislative Assembly.

Expenses are published online and reported by the Alberta Legislative Assembly Office. Receipts are included in the reporting where applicable.
